Applicant acknowledges that the water being purchased is in an untreated condition and that the water obtained from a hydrant is not for human consumption. Applicant knowingly, completely, and freely accepts this and agrees to hold the City of Millersburg harmless from any claims attributable to hydrant water purchase and from any illness or injury that might arise directly or indirectly from the use of such water from the hydrant.

If using the City of Millersburg's hydrant meter, applicant acknowledges that this equipment is on loan. Applicant assumes all risk and all damages to the applicant, the City's property, or private

property, and by signing below the applicant agree to hold the City harmless against any damage that may occur by the applicant's use of the metering device and/or the hydrant, including, without limitation, damage to any City property. The following instructions must be followed:

- The City, or its designee, will install and remove the meter.
- Open and close the hydrant slowly to prevent water hammering.
- To use only a hydrant wrench to open and close the hydrant (no pipe wrenches).

When a hydrant is to be used for an extended period of time, it must be opened all the way to prevent leaking at the drain hole.

- Never leave hydrant open when not in use.
- Never leave wrench or hose on the hydrant overnight or unattended.
- Never leave caps off hydrant.
- When filling a truck or tender, it must have an approved backflow device or air gap.
- The City is to inspect after hydrant use is completed.
- The City reserves the right to require a NPDES permit before approving this application.
- The City reserves the right to remove the water meter and revoke permission to use the meter at any time for any reason.

### **Hydrant Water Purchase Agreement & Permit**

I (we) the undersigned do hereby agree to purchase water from the City of Millersburg at the cost of \$2.25 per 100 cubic feet, plus a \$126.84 monthly base charge. This is a one-time entitlement and does not constitute a right to water in the future.

Furthermore, we do hereby acknowledge and accept that the water is being purchased in an unwarranted condition from a hydrant that is not designed to provide water for human consumption, and the City of Millersburg is not responsible for the containers in which water is transported. I (we) knowingly, completely, and freely accept the risk, and I (we) agree to hold the City of Millersburg harmless from any and all claims attributable to this purchase, and from any illness or injury which might arise directly or indirectly from the use of such water or the use of the hydrant.
